OUR MISSION

National Expungement Works (N.E.W.), is a shift to emancipate justice-impacted communities which have been exploited by systemic inequities and injustices. We believe that whatever is allowed to be expunged, sealed, reclassified, set aside in your state, you should be able to show up and address that. We build and restore pathways for generational healing and wealth through our holistic year-round programming which offers legal relief, wraparound services, and advocacy for the expanded access to expungement.





N 2021 At-A-Glance

While we come to the close of the fourth official year of National Expungement Works (N.E.W.), a shift to emancipate justice-impacted communities exploited by systemic inequities, we are also approaching the third year of the global COVID-19 pandemic. As we were able to adapt to changes while navigating challenges, 2021 has emerged as a meaningful year in the history of the organization. The convergence of the virus, its variants, and multiple pandemics, including racial inequity in healthcare, food insecurities, education, economics, and public safety, may have altered our plans, but they did not deter us from our pursuit of understanding, challenging, and reforming the justice system. The unrelenting trauma generated by the resulting economic hardships have only added more harm to the Black and Brown communities that have already been disproportionately impacted by ongoing systemic inequities and injustices. We'd also be remiss if we didn't highlight the anniversaries that took place this year: the 55th year of The Black Panther Party, and the detrimental 50th year of Nixon's War on Drugs. These two drastically different, but equally important, historical events remind us all that we need to come together with the understanding that there is only one action that will allow us to restore and repair our communities, and that is amnesty.

Our Week of Action & Awareness ("WOAA"), still acknowledged as National Expungement Week, took place from September 27- October 3, 2021. Though we were still in the midst of the pandemic, N.E.W. forged ahead with the progressive and preventative measures of 2020 which illustrated it's resilience and the innovation to meet the demands of the moment through the leadership of our dedicated fellows and organizations. Some organizers planned online events, while others found ways to host safe, socially distanced events in their communities.

The N.E.W. 2021 WOAA featured 21 events across 11 cities, 10 of which were held online. Our overall attendance of 1,541 allowed us to focus on our year-round amnesty processes like record clearing, pardoning, job/career assistance, and assisting our fellows time with their events. We are also proud that another 66,846 people began the process of clearing or sealing their records this year, and an additional 1,310 people received services of some kind.

N.E.W. fellows and partnering organizations also worked to feed communities while utilizing and expanding grassroots community fridge projects in various cities and states through the guidance and leadership from our partners at Unincarcerated Minds Inc. We were also a catalyst in gaining national support for the Pennsylvania Sunset Parole Reform and Driving Equity Act in the city of Philadelphia in conjunction with the CannabisNoire and Autozone. Our National Webinars centered powerful information on voting, domestic violence, knowing your rights and financial literacy in association with organizations such as Americans for Safe Access, The Debt Collective, Time Done, and DVWMT (Domestic Violence Wears Many Tags).

In 2020 N.E.W. developed a Fellowship Program and have inspired these dedicated fellows and partnering non-profit organizations to create online platforms for resources, information, and eligibility sessions. However, due to the pandemic restrictions still impacting our nation's courts, our fellows are tasked with communicating delays to those eligible for legal relief across the country. Although COVID alone cannot be blamed for the backlog in cases, it created additional delays in securing justice and healing in our systematically ravaged communities. Records show that there have been record clearing backlogs in states like Illinois and Georgia for more than 3 years. To assist with this, we have committed ourselves to find effective legal partnerships while strengthening the impactful resources we currently utilize.

Since 2019 our ongoing partnership with Canopy Growth Corporation has not only allowed us to continue working with communities to overcome the 48,000 collateral consequences facing those formerly incarcerated, but also to assist us in expanding and strengthening public awareness around racial profiling, stacked charges, and understanding our legal rights. Canopy Growth was also instrumental in connecting us with legal powerhouse, Dentons, who eagerly lent their assistance for us to better utilize the Collateral Consequences Resource Center to find better ways to mitigate court-related backlogs and to solidify our 501c3 status, among other services.

Automatic Record Expungements in Los Angeles in 2021

Marking the third year of our growing partnership with Code For America (CFA), they hosted their 9th annual National Day of Civic Hacking in early September. We've continued to foster collaborations between CFA's network of volunteer brigades and our community-based organizers, as it deepens the bond between organizations and our complementary missions and services.



Now assisting 5 counties in California, N.E.W. and CFA stepped up to the challenge of assisting organizing partners, The Social Impact Center, to support Los Angeles County District Attorney George Gascón in identifying nearly 66,000 cannabis convictions that will be dismissed as part of his ongoing efforts to reverse the injustices of drug laws.


The combined efforts of such powerful forces, along with the Los Angeles District Attorney's Office, helped to shine a light on the importance of automatic expungement, as those who qualify may not even know that they are eligible. The path was paved for the cannabis related expungements by the original prop 47 which lowers specific non-violent property and drug crimes from felonies to misdemeanors, and will account for thousands of future automatic record expungements.

2021 Public Benefit Created



WHO'S INVITED TO THE COOKOUT?

Our fourth annual observance of Juneteenth was held on June 19th, 2021. 'The cookout' as defined by UrbanDictionary.com, is "a metaphorical gathering of the Black community," exclusive to it's members except for those who receive an invitation. The question ultimately posed by N.E.W. is regarding who is welcomed into Black spaces and how that correlates to allyship, wellness, social responsibility, and economic and political justice.

As with their groundbreaking work to center expungement in harm reduction, N.E.W.'s annual Juneteenth community celebrations helped ignite the movement that blossomed into a federal holiday. The day June 19 has additional significance for the organization as N.E.W.'s genesis can be traced to a barbeque to mark the holiday in 2018.

perspectives on legislation and its compounded impact on the Black community, and healing practices for coping, surviving, and thriving within this system of injustice," said Jessica Jackson, 2021 Director of Ops for N.E.W. These conversations are necessary when honoring the legacy of Juneteenth and celebrating in fellowship with our community.

Media Spotlight

Our community and social outreach strategies, both organic and paid, were adapted due to the quarantine, however digital campaigning, television appearances, and news coverage by mainstream outlets such as Forbes, Politico, LA Times Weekly, and USA Today, still helped to amplify public awareness. Our social media platforms created a 4% increase in engagement from 2020, with 138,263 social media impressions combined; and our total online + print audience reached 312,961,161 with 133 news clip mentions.





Takeaways

Since it's launch in 2018, N.E.W. has helped 68,459 people begin the process of clearing their record, and 8,480 people have received vital services of some kind. N.E.W. events feature a combination of wraparound services that include, but are not limited to: legal relief (record clearance and/or sealing), education about changes in record clearance policy, employment workshops, fine and fee reduction, free food and produce giveaways, health screenings, voter registration, and other services needed by individuals and communities that have been harmed by the War on Drugs.

LOOKING AHEAD

In addition to our year-round community work, our incarcerated loved ones are still living in cruel, inhuman, and degrading conditions that put them at high risk of contracting COVID. Data from prisonpolicy.org shows that under 50% of people in prisons nationwide have received even one dose of a coronavirus vaccine, and there are 15 states that have only vaccinated 60% or less of incarcerated people. This has made it imperative that we advocate for our family members who should no longer be caged or confined to a cell. We adjusted our social media platforms and created an outlet to impart information to those preparing to return home as we are still experiencing increasing wait times to remove charges. We also created a forum where those who are incarcerated, or their loved ones, can share their story and let us know ways that N.E.W. and our communities can get involved. For example, Tony Lewis Jr. shared during our 4th annual Who's Invited to the Cookout: Juneteenth Celebration, that his father has been in prison for 32 years on a life sentence for a non-violent drug offense. That's 6 presidents, 3 full wars, including both Iraq wars and the war in Afghanistan, which is recognized as the longest war in American history, outside of Nixon's War on Drugs! Our solidarity partners, Cage-Free Repair, have guided our digital campaigns surrounding the incarceration system and post-conviction care, and continue to amplify our objectives on freeing and healing our loved ones on the inside, and out. This partnership will also allow us to conduct our first ever T.R.A.P. (The Real Amnesty Project) global call since experiencing the pandemic. This call to action will be a testimonial to the universal acknowledgement of what these systemic injustices are, who they impact, and what it looks like to heal, balance and build from these traumatic harms.

One of 2022 organizing partners, Clean Slate Wisconsin will be leading our fellowship program of the "Ban the Box," campaign.

N.E.W. was also able to start the process of putting resources into action in recognition of Black August, by starting the OPP (Our People's Process) Resource Database. We did that by instituting an online and word-of-mouth campaign asking the nation to tag us with all Black-owned businesses. There are plans to launch this initiative on our website by March 2022.

Because of the tragic reminders of Malcolm Williams and Philando Castile, we've launched our 2022 Brakelight Clinic Series in hopes that the momentum will encourage every city to create a Driving Equity Bill while protecting and educating our communities.
